# उपेक्षा पर सरकार से मांगा जवाब

स्वामिमान पक्ष (पार्टी) के राजू शेटी ने 1952 के हेलसिंकी ओलंपिक में कांस्य पदक जीतने वाले पहलवान खाशाबा जाधव का मामला उठाया और उन्हें मरणोपरांत पदम पुरस्कार से सम्मानित किए जाने की मांग की। उन्होंने कहा कि उनका बेटा इतनी गरीबी में है कि वह अपने पिता के पदक को बेचने को मजबूर हो रहा है। यह पहली बार था जब किसी भारतीय एथलीट ने व्यक्तिगत पदक हासिल किया था। शेटी का कहना था कि इतनी बड़ी उपलब्धि के बावजूद जाधव को कभी पदम पुरस्कार नहीं मिला।

कांग्रेस के केसी वेणुगोपाल ने जानी-मानी एथलीट पीयू चित्रा को लंदन में होने वाले विश्व एथलीट मुकाबलों में जाने की इजाजत नहीं मिलने का मामला उठाया और कहा कि

खेल संघ इस मामले में किसी की नहीं सुन रहा है और हाई कोर्ट का आदेश भी धरा का धरा रह गया। उन्होंने कहा कि केरल के एक अत्यंत गरीब और पिछड़े परिवार से आने वाली चित्रा ने कई अहम राष्ट्रीय और अंतरराष्ट्रीय मुकाबलों में अपनी चमक बिखेरी और मेडल हासिल किए हैं। लंदन मुकाबले के लिए माना जा रहा था कि चित्रा को अपनी निरंतर मेहनत का इनाम जरूर मिलेगा लेकिन वो इस मुकाबले में जा नहीं पाई और उनका सपना बिखर गया। कांग्रेस के अधीरंजन चौधरी ने दिशा की बैठकों में उन्हें आमंत्रित नहीं किए जाने का मामला उठाया और कहा कि इस प्रकार पश्चिम बंगाल में लोकतंत्र कैसे बचेगा। माकपा के एमवी राजेश ने रणनीतिक महत्व के लोक उद्यमों के विनिवेश के फैसले पर सरकार से पनविचार करने की मांग की। तृणमूल कांग्रेस की अपरूपा पोद्दार, भाजपा के संजय पाटिल, वीरेंद्र कुमार और गोपाल शेटी ने भी लोक महत्व के मुद्दे उठाए।

नई दिल्ली, 4 अगस्त (भाषा)।

फीफा अंडर-17 विश्व कप की स्थानीय आयोजन समिति के टूर्नामेंट निदेशक जेवियर सेप्पी ने शुक्रवार को कहा कि राजधानी का जवाहर लाल नेहरू स्टेडियम इस महत्वपूर्ण फुटबॉल प्रतियोगिता के मैचों की मेजबानी के लिए 95 फीसद तैयार है।

उन्होंने देश भर के फुटबॉल प्रेमियों से भी भारत में पहली बार हो रहे फीफा टूर्नामेंट में भारतीय टीम का हौसला बढ़ाने के लिए कहा जो पहली बार इस तरह की प्रतियोगिता में हिस्सा लेगी। सेप्पी ने कहा कि स्टेडियम में काफी काम हुआ है और काम बहुत अच्छा हुआ है। स्टेडियम 90 से 95 फीसद तैयार है। प्रशंसकों को अधिक उत्साह दिखाने की जरूरत है। उन्होंने कहा कि टिकट बिक्री में निश्चित तौर पर बढ़ोतरी हुई है।
