शुद्ध पुलिस द्वारा अबेश दास गुप्ता की मौत के मामले में हत्या की बात को खारिज करने के एक दिन बाद उसकी मां ने आज मुख्यमंत्री ममता बनर्जी से इंसाफ पाने के लिए मुलाकात की और कहा कि उन्होंने उन्हें मदद का आश्वासन दिया है।

अबेश की मां रिमझिम दासगुप्ता ने मुलाकात के बाद संवाददाताओं से कहा, मुख्यमंत्री ने हमने से उनमें विश्वास रखने को कहा है। उन्होंने हमें आश्वासन दिया है कि सच सामने आएगा। उन्होंने कहा कि अपराधियों की तलाश की जाएगी। अपने परिवार के अन्य सदस्यों के साथ मुख्यमंत्री से मुलाकात करने वाली रिमझिम ने कहा, मैंने उन्हें बताया कि कई सवाल अब भी ऐसे हैं जिनके जवाब नहीं मिले हैं।

रिमझिम ने गुरुवार को कोलकाता के संयुक्त पुलिस आयुक्त (अपराध) विशाल गर्ग से मुलाकात की थी। उन्होंने कहा, गर्ग ने मुझे बताया था कि मामले की जांच अब भी चल रही है। कई जांचों को अभी पूरा किया जाना है। उन्होंने मुझे सीसीटीवी फुटेज पर अवगत कराने के लिए बुलाया था।

उन्होंने कहा कि सीसीटीवी फुटेज में उस दिन का पूरा घटनाक्रम नहीं है। गर्ग ने मामले में हत्या होने की बात को खारिज करते हुए कहा था कि 17 वर्षीय युवक की मौत 23 जुलाई को सन्नी पार्क आवासीय कॉम्प्लेक्स के लॉन को एक छोटी दीवार से गिरने से उसे लगी चोट के कारण हुई थी।
