As per Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management & Administration) Rules, 2014, as amended, and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to provide the facility to its members to exercise their right to vote by electronic means from a place other than the venue of meeting (remote e-voting). The Company has engaged the services of Central Depository Services (India) Limited (CDSL) as authorized agency to provide remote e-voting facility. The details of the remote e-voting are as under:

1. Date and time of commencement of remote e-voting: **September 26, 2016 (9:00 a.m.)**
2. Date and time of end of remote e-voting: **September 28, 2016 (5:00 p.m.)**
3. The remote e-voting shall not be allowed beyond **September 28, 2016 (5:00 p.m.)**
4. A person, whose name appears in the register of members / beneficial owners as on the cut-off date i.e. September 22, 2016 shall only be entitled to avail the facility of remote e-voting as well as voting at the meeting.
5. A person, whose name appears in the register after dispatch of the Notice of the meeting and holding shares as on the cut-off date, may obtain the USER ID and password by following the detailed procedure as provided in the Notice of the meeting which is available on the Company's website and CDSL's website. If the member is already registered with CDSL for e-voting then he can use his existing USER ID and password for casting the vote through remote e-voting.
6. A facility of voting through ballot paper shall also be made available at the AGM and members attending the meeting who have not already cast their vote by remote e-voting shall be able to exercise their rights to vote at the meeting.
7. The members who have cast their vote by remote e-voting prior to the meeting may attend the meeting but shall not be entitled to cast their vote again.
